

Win a Home Makeover Contest (6 July to 7 September 2017) Terms and Conditions

1. Guardian Health And Beauty Sdn. Bhd. and Petron Fuel International Sdn Bhd (collectively referred to as “Organizers”) will launch a contest known as „Win a Home Makeover Contest (“Contest”) starting from 6 July 2017 at “00:00:01” to 7 September 2017 at 23:59:59” (“Contest Period”). The Organizers shall reserve the right to shorten, change, revise or amend the Contest Period at any time without prior notice. All contest form and/or online entries received outside the Contest Period will be disqualified.
2. Participants are eligible to participate in the Contest with a minimum purchase of RM10 in a single receipt from any participating Guardian store and Guardian E-store in Malaysia or spend a minimum of RM10 of fuel purchase of Petron fuel products (excluding Diesel) and swipe the purchase with a validly registered Petron Miles Privilege Card at any participating Petron service stations in Malaysia during the Contest Period.
3. The proof of purchase (“POP”) for each entry is the original Guardian receipt or online tax invoice received after purchasing which contains the Receipt Number, Date of Purchase and Receipt Value. Receipts MUST be issued from Guardian stores in Malaysia only. You may participate in the Contest via contest form and website.

HOW TO PARTICIPATE

A. Via Guardian Contest Forms

Contest forms are only available in Guardian stores.

Step 1: Participants must purchase min of RM10 from any Guardian stores or Guardian E-store (POP must be kept to staple with the contest form)

Step 2: Contest forms will be given to customers after purchase.

Step 3: Participants are encouraged to fill up the form on the spot and answer questions given.

Step 4: Participants to staple the receipt (POP) to the contest form and submit it into the box placed on top of the cashier counter.

B. Via Guardian Contest Website

Step 1: Participants must purchase min of RM10 from any Guardian stores or Guardian E-store (POP must be kept for verification purpose)

Step 2: Participants need to log on to the contest website www.myguardian.com.my/homemakeover and key in full name, IC number, contact number, email address, purchase amount and receipt number in the given space.

C. Via Petron
